- 1. Organizations wishing to use facilities at Lewis County Fairgrounds shall first apply to the Lewis County Fair Manager on the above form. The Board of Directors has final approval. The applicant representing the organization must be at least 21 years of age and a citizen in good standing. The Board of Managers reserves the right to cancel any event at any time if it is deemed unsafe or does not fall under the auspices of an appropriate community event. In such cases, the Board will make every effort to provide timely notice to the event organizer.
- 2. In the event of inclement weather, the Fair Manager and Board of Directors have the final authority on whether facilities are usable.
- 3. All rules must be adhered to.
- 4. Profanity, objectionable language, disorderly acts or illegal activities of any kind are absolutely prohibited, and those violating this prohibition will be ejected from the premises.
- 5. No alcoholic beverages may be sold on the premises without prior approval or without providing the Licensor with municipal liquor licenses and liability insurance covering liquor-related liability (\$1,000,000). All documentation must be submitted at least two (2) weeks prior to the event.
- 6. Any damage to facilities or property shall be promptly repaired at the Licensee's expense. No exceptions. If maintenance personnel are not available, make sure all doors are locked and lights are turned out when leaving. Any cleaning or repairs necessary will be charged to the Licensee.
- 7. Organizations using the facilities must clean up afterwards. (All garbage bagged.) Any cleaning or repairs necessary will be charged to the Licensee.
- 8. The Licensee must adhere to all requirements of the NY State Electrical Code and County Health Department regulations regarding food service. Fire extinguishers must be provided for food stands and displays as per fire safety regulations.
- 9. Any organization with youth under 18 years old requires the presence of adequate adult (21 & over) supervision at all times.

10. INDEMNIFICATION AND HOLD HARMLESS

To the fullest extent permitted by law, _________("Licensee"), Agrees and Its own cost to defend, indemnify and hold harmless Lewis County Agricultural Society, ("the Society"), its officers, directors, shareholders, agents, representatives, managers, employees and affiliates from and against any and all claims, suits, liens, judgments, damages, losses and expenses including reasonable attorney fees and legal expenses and costs arising in whole or in part, including but not limited to any deductibles, and in any manner from the acts, omissions breach or default of Licensee, in connection with the performance of any work by Licensees, its officers, directors, agents, and employees. This agreement is continuous until terminated by either

party with written notice.

INSURANCE

Licensee hereby agrees that it will obtain and keep in force insurance policy/policies to cover its liability hereunder and to defend and save harmless the Society in the minimum amount of \$1,000,000 per occurrence \$2,000,000 aggregate for bodily injury, property damage, and personal and advertising injury.

Said liability policies shall 1) name the Society as an Additional Insured and 2) be primary and non-contributory to any other insurance policies which provide insurance protection to Society.

The Licensee will obtain and keep in force Workers Compensation Insurance including Employers Liability to the full statutory limits.

Licensee acknowledges that failure to obtain the insurance as set forth above on behalf of the Society constitutes a material breach of contract and subjects it to liability for damages, indemnification and all other legal remedies available to the Society. The Licensee is to provide the Society with a certificate of insurance, evidencing the above requirements have been met prior to use of the facilities. The failure of the Society to object to the contents of the certificate or the absence of it shall not to be deemed a waiver of any and all rights held by the Society.

11. This Contract supersedes all oral agreements and negotiations. Alterations or amendments must be in writing and signed by both parties.
